

Modular Service Platform

Current Situation | The extension API for the Stibo Systems platform allows developers to integrate extensions directly into the Stibo Systems platform application server.

Challenge | During system updates, extensions often rely on specific Stibo Systems Platform versions and can potentially destabilize the entire system. These issues are particularly problematic in a SaaS environment, where debugging capabilities are limited and updates occur more frequently.

What's New | With 2025.3, we developed a new Modular Service Platform. It enables the creation of plugins—such as Receivers, Converters, Delivery components, and Business Functions—that run as separate processes.

Expected Benefits | By decoupling these components from the Stibo Systems platform, they become independent of the version and cannot compromise its stability in the event of a failure.

Access to Security Event Logs


Current Situation | As organizations move from on-premise to SaaS, they lose direct access to log files needed for debugging, monitoring, and compliance. Currently, log files must be manually downloaded via the System Admin tool.

Challenge | This manual process is slow and lacks rolebased access control. It hinders developers who need realtime logs for debugging and administrators who rely on continuous access for monitoring and audit purposes.

What's New | With 2025.3, we are introducing UI access to Security Events.

Expected Benefits | This enhancement lays the foundation for extending STEP with access to other log information, like JavaScript logging, activity, etc.









JavaScript Additions

Extending API with New Functional Areas

With 2025.3, enhanced JavaScript capabilities now enable direct management of attributes, workflows, publications and file operations—bringing greater automation, flexibility, and control to business rule development. It is now possible to:


Attributes and List of Values | Create and manage attributes and lists of values directly from JavaScript, using the same methods that were previously available only through Extensions. This enhancement simplifies the synchronization of attribute definitions between systems.

Workflow State | Inspect the type of a workflow state (e.g., initial, final, parallel) as well as its transitions (source and target). This enables more advanced and conditional logic within workflows.

Publications | Create and maintain publications and sections using JavaScript business rules, allowing for greater automation and efficiency in managing publication workflows (screenshot).

File Operations | Create and manage temporary and/or process files in BLOB storage, allowing the sharing of context among business rules or the Modular Service Platform.

Turning Off Reflection

Current Situation | Historically, it has been possible to use reflection in JavaScript business rules to access non-public methods in the API. In version 2023.3, checks were introduced to detect and report the use of reflection through health checks, the step.0.log, and diagnostics metrics. These tools helped identify where reflection was being used so developers could begin transitioning to public APIs.

Challenge | While this provided flexibility, it introduced significant risks—such as database inconsistencies, performance issues, and unexpected problems during platform upgrades.

What's New | With 2025.3, and after multiple warnings, the use of reflection has now been fully blocked.


Expected Benefits | This change improves platform stability, ensures better performance, and reduces the risk of upgrade-related issues. For support during this transition, users are encouraged to contact their Stibo Systems representative.

Automated Vendor Portal Setup for Suppliers



Current Situation | As more customers adopt our vendor onboarding capabilities, reliance on scripts and technical teams to set up portals has become a bottleneck.

Challenge | Vendor portal setup depends on manual intervention, slowing down scaling of the PDX Onboarding solution.

What's New | With 2025.3, to streamline onboarding and reduce manual effort, we are introducing automated vendor portal creation tied directly to PDX onboarding channels. Channel admins can now activate or disable Vendor portals with a single click, using default branding and naming conventions.

Expected Benefits | This enables faster, scalable setup, better resource efficiency, and a smoother onboarding experience for both retailers and their vendors.

Stibo Systems MDM SmartSync for Salesforce

Current Situation | Salesforce is a dominant CRM application and typically an origination point for master data and key consumer of customer master data from the Stibo Systems platform. Seamless bi-directional data flow between Salesforce and MDM is vital for efficiency and currently required custom development.

Challenge | While current integrations are common using existing capabilities, clients demand a rapid and best practice approach to ensure efficient Salesforce integration and future proofing.


What's New | After a successful early adopter release the Salesforce Connector becomes Generally Available with 2025.3.

Expected Benefits | Accelerate value with enhanced interoperability between Stibo Systems and Salesforce. This Lightning-optimized app streamlines bi-directional data sync, supports merging and search-beforecreate, and includes a best-practice implementation for faster, smoother deployments—with forward compatibility for future Salesforce updates.



ProductGen Al

Current Situation | Need to enable customers to leverage Generative AI from within their existing Stibo Systems platform to enhance product data content.

Challenge | Customers want to explore Generative AI, but doing so outside their MDM environment adds complexity and risk—making it hard to experiment safely and at scale.

What's New | 2025.3's Azure OpenAl service lets customers use Generative AI to generate content from solution-specific prompts, generate Al-assisted translations in supported languages, and define data quality rules using Natural Language Processing (NLP) to determine what is allowed or not allowed.

Expected Benefits | Streamlined content creation, simplified data quality management through NLP, and secure AI experimentation within the trusted Stibo Systems environment.

Persistent Filters in Task Lists and Search Results



Current Situation | In the Web UI, users often rely on filters in task lists and search result pages and other node lists to focus on relevant product data.

Challenge | Users lose their applied filters when navigating away from task lists or search results, leading to inefficiency and frustration.

What's New | With 2025.3, we're introducing persistent filters that retain user-defined criteria across sessions and contexts. List filters are locally stored, streamlining workflows and boosting productivity.

Expected Benefits | This reduces unnecessary clicks, improves user satisfaction, and supports scalability as usage grows.

Automated Data Sheet Creation

Current Situation | The Datasheet Creation Processor currently processes paginations sequentially, underutilizing system resources and slowing down datasheet generation.


Challenge | Customers using third-party DAMs need more flexibility in how and where generated PDFs are stored, while others require control over asset hierarchy depth and naming.

What's New | With 2025.3, we are enabling parallel pagination to improve performance, offering options to use external DAMs for PDF storage, allowing control over the creation of asset hierarchy levels, and removing unnecessary prefixes in asset names.

Expected Benefits | These improvements will speed up operations, reduce reliance on custom extensions, and provide a more flexible, customer-friendly experience.

Privilege Control for Complex Enterprise Data



Current Situation | Customer data access rules vary across regions and business units, with exceptions that current privilege models can't handle well.

Challenge | Given the complexity of business operations—spanning lines of business, banners, and regions—clients require multi-dimensional controls to manage which legal entities users can access and work with. Such controls are essential for compliance with regulatory and reporting requirements.

What's New | With 2025.3, we are allowing Entities to inherit privileges via the Entity Reference Types that are parent-child relationships.


Expected Benefits | Enabling granular access control, will support workflows, and will better align with complex organizational structures.

Multi Language Experience



Current Situation | PDX onboarding channels support multiple languages, helping suppliers work across markets using familiar local language settings (2024.1 - PDX UI in my Local Language, 2024.4 - Language Specific LOVs, 2025.1 - Product Data Onboarding Localization.

Challenge | Users report inconsistencies in translations— especially with UI elements like attribute names or category names. The default language plays a key role in data handling but isn't always clearly managed.

What's New | With 2025.3, suppliers get better control over language settings, including defining a default language, clearer UI indicators, and automatic setup during login.

Expected Benefits | These updates improve translation consistency, reduce confusion, and make the onboarding process smoother for multilingual users across all markets.

Accelerating the New UI Updates

Current Situation | The Stibo Systems platform is currently deployed as a monolithic application with quarterly release cycles, limiting flexibility and slowing down delivery of updates for the New UI.

Challenge | Customers may face delays and disruptions in receiving updates to the New UI when its release is tied to the Stibo Systems platform's quarterly cycle, limiting timely access to new improvements and critical functionality.

What's New | With 2025.3, we are decoupling the New UI from the Stibo Systems platform, removing its dependency on its release cycle, enabling faster, independent updates.

Expected Benefits | This flexibility will enable faster development cycles and accelerate the New UI's adoption by allowing teams to respond guickly to customer needs. It supports our continuous updates strategy while minimizing downtime - ultimately improving customer satisfaction and reinforcing trust.

New UI Usability Improvements

Current Situation | Users rely on the New UI to perform bulk enrichment tasks efficiently, requiring clear guidance, better task visibility, and streamlined workflows to enhance overall enrichment productivity.

Challenge | Growing demands for faster time to market are driving more complex task management and workflows, reinforcing the need for improved error visibility and enhanced day-to-day usability within the application.

What's New | Here are five usability enhancements designed to improve general usability in the New UI

- **Drag-to-Fill References & Links:** Bulk edit fields with ease.
- Copy-Paste References & Links: Paste values across multiple products.
- **Anchored Tabs:** Tabs remain visible while scrolling.



Seamless Access to External Content in the New UI



Current Situation | Many customers need access to external data—such as enhanced content, 3D models, or BI dashboards—during their workflows. However, the New UI does not support fetching or rendering this information.

Challenge | The inability to display external content creates a fragmented experience, forcing users to switch between platforms to gather necessary information. This disrupts productivity and leads to frustration.

What's New | With 2025.3, we have introduced a new tab type that allows users to view external content within the UI while working on a specific item — eliminating the need to switch platforms.

Expected Benefits | This enhancement enables users to work more seamlessly and efficiently, improving overall productivity and workflow continuity.

New UI Access to Web UI and External Tools



What's New | With 2025.3, we are introducing seamless, SSO-based linking from the New UI to both the Web UI and external resources such as training materials and documentation.

Expected Benefits | This gives users easy access to missing features and content, making the transition smoother, speeding up adoption, and improving overall usability of the New UI.






